Walk-in Bath Tub Limited Warranty**

Please note: Immediately after installation of this Walk-in Bath Tub, the document following this warranty titled “Princess-30 Warranty Activation” must be completed by the homeowner or contractor installing the bathtub. The customer’s name and address must appear on this document and the document must be sent to Clarion Bathware at the address supplied on the warranty activation form. The warranty described below applies only to the original customer whose name appears on the warranty activation form. Neither this warranty nor any individual parts of this warranty are in any way transferable.

Clarion Bathware warrants all Walk-in Bath Tub accessories to be free of defects in workmanship and material under normal use and conditions for a period of twelve (12) months from the original date of purchase. Accessories include only original accessories supplied by Clarion Bathware. This includes: the controls, spigot, handheld shower, tub spout, overflow and drain assembly, hydrotherapy air jet system, door handles and door closing mechanism.

Clarion Bathware warrants the Walk-in Bath Tub to be free of defects in workmanship and material under normal use and conditions for a period of five (5) years from the original date of purchase. Should service be required to the Walk-in Bathtub by reason of any defect or malfunction of the product during the warranty period, Clarion Bathware will replace or repair the part or product without charge subject to verification of the defect or malfunction.

Clarion Bathware warrants the door seal for a period of five (5) years from the original date of purchase. If the door seal should need replaced, the replacement door seal shall be issued to the customer and it will be the responsibility of the customer to determine the means of installation. Clarion Bathware will not be liable for any incidental expenses or material charges in connection with the removal or replacement of the door seal.

Clarion Bathware will not be responsible for any water damage to structures or property or damage to the Walk-In Tub’s hydrotherapy air jet system. Clarion Bathware will assume no responsibility for the loss of the system, inconvenience due to loss, damage to real or personal property or any other consequential damage. Additionally, Clarion Bathware will not be liable for incidental expenses or material charges in connection with removal or replacement of original parts of the hydrotherapy system.

This warranty shall not apply to any type of failure resulting from negligence, abuse, misuse, improper installation, alteration or modification, chemical corrosion, or improper maintenance. There will be a charge for replacement parts or replacement of the component if the defective item is returned for any of the reasons listed above.

Clarion Bathware reserves the sole authority to make any type of warranties or representations concerning Clarion Bathware or its products and will not be responsible for any warranties or representations made by any outside source, including dealers, retailers, distributors or contractors.

Clarion Bathware does not warrant the installation of this Walk-In Bath Tub. Improper or negligent installation of the product or other components, alterations made to the Walk-In Bath Tub, or alterations or modifications to the system, may cause the product or the system to malfunction. Such problems are not covered by the warranty supplied by Clarion Bathware.
